Opposition to SBC Motion for Expedited Treatment

Comes now the Missouri Independent Telephone Company Group (MITG) and, in opposition to SBC's July 19, 2005 Motion for Expedited Treatment, states as follows:

- 1. SBC's Application for Rehearing/Variance/Waiver was ostensibly electronically filed by SBC on July 14, 2005. Counsel for the MITG was served electronically by SBC with said Application at approximately 4:41 PM, July 14.
- 2. Counsel for the MITG was served electronically with SBC's request for expedited treatment four days later at approximately 4:48 PM July 19.
- 3. The Order of Rulemaking was published on June 15, 2005. SBC had a month to prepare its Application. SBC knew, or should have known, at the time its application was filed, that it would request a ruling by July 30.
- 4. SBC should have filed its request for expedited treatment simultaneously with the filing of its Application. 4 CSR 240-2.080(16)(c) required SBC to explain why the request for expedited treatment could not have been filed sooner. SBC's Motion failed to comply.
 - 5. The MITG intends to respond in opposition to SBC's Application.
- 6. The MITG needs the full ten days until July 25, 2005 in which to prepare and file its response.
