# ORDER PERMITTING RESPONSES TO TIME-SHARE CUSTOMER ISSUE

On February 26, 2018, Orange Lake Country Club, Inc. and Silverleaf Resorts, Inc. ("Movants") filed a reply to Staff and Liberty Utilities' responses to their motion to dismiss. Liberty Utilities' response to the motion to dismiss stated that Movants do not dispute that Liberty Utilities qualifies for the Small Utility Rate Case Procedure ("SURP") because they have fewer than 8,000 customers. Staff's Response to the motion to dismiss states that Movants do not cite any Commission rule or law violated by Liberty Utilities use of the SURP.

Movants reply to Liberty Utilities' and Staff's responses indicates their belief that the 36,686 time-share owners are water and sewer customers within the meaning of 4 CSR 240-3.010(7). Before the Commission decides whether to grant Movants motion to dismiss, the parties will be given an opportunity to respond on the issue of time-share owners as utility customers.

1. No later than March 7, 2018, any party wishing to address the issue of timeshare owners as utility customers may file a response or brief. 2. This order shall be effective when issued.
