## NOTICE OF DISMISSAL OF COMPLAINT AND CLOSING OF FILE

Issue Date: October 2, 2017

The Staff of the Missouri Public Service Commission filed a complaint against Missouri Utilities Company alleging the company failed to submit statutorily required annual reports. The complaint case was stayed while the Commission considered an application to approve the sale of Missouri Utilities Company's water and sewer assets to Elm Hills Utilities. On September 19, 2017, the Commission issued its order in File No. SM-2017-0150 granting the transfer application. On September 29, 2017, Staff filed a pleading to dismiss the pending complaint case against Missouri Utilities Company, stating that with the completion and approval of the sale, it saw no need to pursue its complaint regarding Missouri Utilities Company's annual reports.

Commission Rule 4 CSR 240-2.116(1) provides that a complainant may dismiss its complaint at any time before prepared testimony has been filed without an order from the Commission. No prepared testimony has been filed in this case, so Staff does not

need leave to dismiss its complaint. The Commission takes notice of the dismissal. This file shall be closed.
