ORDER SETTING DEADLINE FOR FILING ANNUAL REPORTS

Issue Date: November 2, 2016

Effective Date: November 2, 2016

On October 31, 2016, the Court-Appointed Receiver for Osage Water Company submitted a *Status Update of Receiver and Request for Additional Time to File Annual Reports*. The Receiver states that an accountant was retained to assist in the preparation of the 2013, 2014, and 2015 Annual Reports, but additional time is needed. The Commission will grant Osage Water Company's request for a November 30 deadline to submit the Annual Reports.

THE COMMISSION ORDERS THAT:

1. No later than November 30, 2016, Osage Water Company shall submit its 2013, 2014, and 2015 Annual Reports to Staff and the Office of the Public Counsel.
2. No later than December 16, 2016, the Commission's Staff shall file a status report stating if Osage Water Company is in compliance with this order and if Staff wishes to pursue its complaint.

3. This order shall be effective when issued.
