On October 13, 2016, Osage Water Company filed a request for additional time to submit past due Annual Reports. The Commission will grant Osage Water Company's request for an October 31 deadline to file its Annual Reports. The Commission will also extend the deadline for the Commission's Staff to submit a status report on the company's compliance with this order.

**THE COMMISSION ORDERS THAT:**

1. No later than October 31, 2016, Osage Water Company shall submit its 2013, 2014, and 2015 Annual Reports to Staff and the Office of the Public Counsel.
2. No later than November 30, 2016, the Commission's Staff shall file a status report stating if Osage Water Company is in compliance with this order and if Staff wishes to pursue its complaint.

3. This order shall be effective when issued.

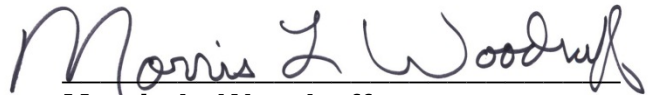
