## ORDER SETTING PROCEDURAL SCHEDULE AND OTHER PROCEDURAL REQUIREMENTS

The Commission directed the Commission's Staff to file a joint proposed procedural schedule, and Staff complied with that order on February 15, 2018. The Commission will adopt the proposed procedural schedule and order additional procedural requirements.

#### THE COMMISSION ORDERS THAT:

1. The following procedural schedule is established:

Date	Event
February 25, 2018	Last day to submit data requests
March 7, 2018	Last date to answer data requests
March 12, 2018	Parties submit stipulation of undisputed facts
March 22, 2018	Evidentiary hearing

2. The evidentiary hearing is scheduled for March 22, 2018, beginning at 9:00 a.m. The hearing will be held in Suite 105 of the Wainwright State Office Building, 111 N. 7<sup>th</sup> Street, St. Louis, MO 63101. Any person requiring additional accommodations to participate in the hearing shall call the Missouri Public Service Commission's Hotline at 800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

- 3. The parties shall comply with the following additional procedural requirements:
  - A. All parties shall bring an adequate number of copies of exhibits that they intend to offer into evidence at the hearing. If testimony or documents are pre-filed and served on the parties before a hearing, a party need only provide a copy of the testimony or document to the court reporter as an exhibit at the evidentiary hearing. If an exhibit has not been prefiled, the party offering it must bring, in addition to the copy for the court reporter, copies for the five Commissioners, the Presiding Judge, and all counsel.

- C. Each party shall prepare a list of its pre-filed, pre-marked exhibits and submit a copy of that list to every other party and to the regulatory law judge no later than the morning of the evidentiary hearing.
