4 **Q. PLEASE STATE YOUR NAME.**

5 A. My name is Kathy Rose.

6 **Q. ON WHOSE BEHALF ARE YOU APPEARING FOR THE PURPOSES OF THIS**
7 **SURREBUTTAL TESTIMONY?**

8 A. I am appearing for the purposes of this testimony on behalf of intervenor City of
9 Riverside (the "City"). The City receives service directly and its residents also receive
10 service from Missouri-American Water Company ("MAWC").

11 **Q. PLEASE DESCRIBE YOUR EMPLOYMENT.**

12 A. I am the Mayor of the City.

13 **Q. WHAT IS YOUR INTEREST IN THIS PARTICULAR CASE?**

14 A. I am testifying as a representative of the City, which is attempting to protect its citizens in
15 the present case. The City is within the Parkville District, subject to the Platte County
16 water tariff at issue in this case.

17 **Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY?**

18 A. The purpose of my testimony is to address whether the City supports a consolidated tariff
19 pricing or rate structure.

1 **Q. DOES THE CITY SUPPORT CONSOLIDATED TARIFF PRICING OR RATE**
2 **STRUCTURE, AS REQUESTED BY MAWC IN THIS CASE?**

3 A. Yes.

4 **Q. BASED ON THE FOREGOING, WHAT RELIEF ARE YOU REQUESTING IN**
5 **RELATION TO THIS ISSUE?**

6 A. The City believes that a consolidated rate structure should be adopted. Therefore, the
7 City requests that consolidated tariff pricing or rate structure be adopted in this case.
