which interested persons may testify.<sup>3</sup> The Commission granted that request,<sup>4</sup> and will reset<sup>5</sup> the local public hearings on the date requested by both OPC<sup>6</sup> and Staff,<sup>7</sup> as near as possible to the locations requested by OPC.<sup>8</sup>

## THE COMMISSION ORDERS:

- 1. **Settings**. The Commission will convene local public hearings on the proposed rate adjustments on November 19, 2015, as follows:
  - a. <u>Forsyth</u>, 11:30 a.m. in the Forsyth High School Auditorium, 178 Panther Street, Forsyth, MO 65653. The local public hearing will begin with a question-and-answer session. At 12:30 p.m., the question-and-answer session will conclude and the Commission will take testimony.
  - b. Ozark, 5:30 p.m. in the Municipal Court Room, 203-B East Brick Street, Ozark, MO 65721. The local public hearing will begin with a question-and-answer session. At 6:30, p.m., the question-and-answer session will conclude and the Commission will take testimony.

## 2. Notice.

a. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the County Commissions of Christian County, Taney County, and Stone County, Missouri.
