- 1. The Commission on July 12, 2016, issued its *Report and Order* in the above-referenced matters. On July 14 the Commission issued an order directing the parties to file a detailed reconciliation regarding the dollar value and rate or charge impact of the contested issues in these matters, resolved by the Commission's *Order*.
