**ORDER GRANTING MOTION FOR EXTENSION**

On February 8, 2017, the Staff of the Missouri Public Service Commission filed a *Motion for Extension* requesting the Commission extend the small rate case timeline dates, beginning with Day 90, by 15 days. Commission Rule 4 CSR 240-3.050(12) permits the extension of established small utility rate case timelines by up to 60 days, if Staff and the regulated company agree.

Staff indicates that an extension is needed for Staff to submit its initial investigation report to the other parties. With the Motion, Staff provided an updated Small Rate Case Timeline. Staff states in its Motion that Terre Du Lac Utilities agrees to the requested extension. Staff also states that the Office of the Public Counsel has stated that it is unopposed to the request. The Commission previously granted a 30-day extension. Granting Staff's Motion will not exceed the 60 days extension permitted by the Commission's regulations.

Finding the request to be reasonable, the Commission will grant the extension request and accept the updated Small Utility Rate Case Timeline submitted with the *Motion for Extension*.

**THE COMMISSION ORDERS THAT:**

1. Staff's February 8, 2017 *Motion for Extension* is granted. The updated Small Utility Rate Case Timeline is accepted.
2. This order shall be effective when issued.
