On July 5, 2017, the Commission issued an order scheduling an August 3, 2017 procedural conference to discuss a procedural schedule. The Commission subsequently scheduled oral arguments on Missouri-American Water Company's *Motion to Establish Future Test Year* for August 7, 2017. Since a discussion of the procedural schedule will be more productive after the August 7, 2017 oral arguments, the Commission will reschedule the procedural conference.

THE COMMISSION ORDERS THAT:

1. The August 3, 2017 procedural conference is rescheduled to August 10, 2017, at 11:00 a.m. The procedural conference will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the American with Disabilities Act. 
