Section 386.420.4, RSMo 2016, requires the Commission to cause to be prepared and to approve a detailed reconciliation regarding the dollar value and rate or charge impact of the contested issues decided by the Commission in this case. The Commission will direct Missouri-American Water Company to prepare and file a reconciliation and provide an opportunity for other parties to respond to the reconciliation.

THE COMMISSION ORDERS THAT:

1. No later than July 5, 2018, Missouri-American Water Company shall file a reconciliation.
2. Any party wishing to respond to the reconciliation filed by Missouri-American Water Company shall do so no later than July 13, 2018.
3. This order shall be effective when issued.
