On May 9, 2018, the Commission issued a *Report and Order* regarding Gascony Water Company's ("Gascony") request for an increase in annual water system operating revenues and directing Gascony to submit revised tariff sheets in compliance with that order. - 2. No later than June 7, 2018, any other recommendations regarding the compliance of Gascony Water Company's tariff sheets (Tracking No. YW-2018-0159) with the Commission's May 9, 2018, *Report and Order* may be filed.
