# NOTICE OF TARIFF EFFECTIVE BY OPERATION OF LAW

)

Issue Date: January 18, 2018

The Commission will allow the pending tariff ("tariff") to take effect by operation of law on January 20, 2018, which is the tariff's effective date as extended by Environmental Utilities, LLC ("utility"). <sup>1</sup>

The utility filed the tariff<sup>2</sup> to implement a disposition agreement providing for a full resolution of the utility's request but executed by only the utility and the Commission's staff ("Staff"). <sup>3</sup> Written notice mailed to each utility customer initiated a 20-day comment period that began on the date of the notice,<sup>4</sup> which was December 15, 2017. <sup>5</sup> The twentieth day after that was January 4, 2018. Five working days after the end of the comment period-January 11, 2018—a pleading from the Office of the Public Counsel was due.<sup>6</sup> The Office of the Public Counsel filed no such pleading.
