ORDER DISMISSING COMPLAINT

Issue Date: July 20, 2017 Effective Date: August 1, 2017

The Commission is granting Staff's *Motion to Dismiss*¹ ("motion). The motion cites the Commission's regulation providing:

> The commission, ... on the motion of a party, may after notice dismiss a complaint for failure to state a claim on which relief may be granted [.2]

A complaint fails to state a claim when, assuming that everything alleged in the complaint is true, the Commission has no authority to grant the relief sought. 3

The relief sought in the complaint is an award of money damages,⁴ which is not available at the Commission.⁵ The motion also represents that Bertha Anderson wants to dismiss the complaint because the Commission cannot grant the relief that Ms. Anderson seeks.

The Commission gave Ms. Anderson until July 17, 2017, to file a response. ⁶ Ms. Anderson filed no response. The Commission will grant the motion and dismiss the complaint.

THE COMMISSION ORDERS THAT:

- 1. Staff's *Motion to Dismiss* is granted.
- 2. The complaint is dismissed.
- 3. This order shall be effective on August 1, 2017.
