## ORDER SETTING PREHEARING CONFERENCE

On July 3, 2018, Thirty and 141, L.P., filed a complaint with the Missouri Public Service Commission (Commission) against Missouri American Water Company. Thereafter, the Commission ordered the Staff of the Missouri Public Service Commission (Staff) to investigate and file a report. Staff filed its report on October 5, 2018.

Having received the complaint, the answer, and Staff's report, this matter is ready to be set for hearing. In order to discuss a procedural schedule and possible settlement of this matter, the Commission will set a prehearing conference. In addition, for their convenience, the parties may appear by telephone as set out below.

### THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on November 2, 2018, at 10:00 a.m. Failure to appear at the conference without being excused may result in a default being issued in accordance with Commission Rule 4 CSR 240-2.090(5).

2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. Any party may participate in the prehearing conference by telephone by dialing (573) 526-6207 or (866) 630-9356 at the start time of the conference.
