

APPLICATION FOR CERTIFICATE OF SERVICE AUTHORITY TO PROVIDE INTEREXCHANGE AND LOCAL EXCHANGE TELECOMMUNICATIONS SERVICES

M.L.M. Telecommunications, Inc. dba Ameritel, Your Phone Company ("Ameritel" or "Applicant"), by its undersigned counsel, hereby submits this Application for certificate of service authority to provide interexchange and local exchange telecommunications service in the State of Missouri, and for competitive classification, pursuant to Sections 392.410, 392.430 and 392.440 RSMo. and 4 CSR 240-2.060. Applicant respectfully requests the Commission issue an order that 1) grants Applicant a certificate of service authority to provide intrastate interexchange and local exchange telecommunications services on a statewide basis pursuant to Chapter 392 of the Revised Statutes of Missouri, 2) grants competitive status to Applicant pursuant to Section 392.361 RSMo., and 3) waives certain Commission rules and statutory provisions pursuant to Sections 392.420 and 392.361 RSMo. In support of its application, the Ameritel states as follows:

- 1. Applicant is a corporation duly organized and existing under and by virtue of the laws of the State of Arkansas. The Company is authorized to conduct business as a foreign corporation within Missouri. Documentation required in compliance with 4 CSR 240-2.060(1)(C) has previously been provided to the Commission in Case Nos. CA-2002-1140 (M.L.M. Telecommunications, Inc. CLEC Certificate Application case--Secretary of State Certificate of Good Standing) and CN-2003-0266 (Name Change to M.L.M. Telecommunications, Inc. d/b/a Ameritel, Your Phone Company--Secretary of State Registration of Fictitious Name) and is incorporated herein by reference pursuant to 4CSR 240-2.060(1)(G), as the information therein is current and correct. The nature of Ameritel's business is the provision of telecommunications services. Ameritel's principal place of business address is: 1307 Central Ave, Hot Springs, Arkansas 71901.

3. The Company proposes to provide resold switched long distance interexchange service to business and residential customers on a statewide basis, and may provide local exchange (non-switched private line) services in the future. The Company will not offer operator service services.
4. The Company is a telecommunications company which possesses the technical and managerial expertise to provide the services it proposes.
5. The Applicant also possesses the necessary financial resources to provide the services it proposes.¹
6. In accordance with 4 CSR 240-2.060(6)(C), Applicant is simultaneously submitting its proposed tariff with a forty-five day effective date for approval by the Commission. The tariff contains the rules and regulations applicable to its customers, description of services offered and list of rates associated with such services. The Company requests that the Commission approve its MO P.S.C. No. 3 simultaneously with granting certificate of service authority in this case.

¹Applicant is currently involved in a Chapter 11 bankruptcy case, but anticipates emerging from bankruptcy within the next 90 days. Applicant is and will remain financially capable of providing the resale of long distance services as proposed in this Application and in its concurrent tariff filing.

7. Applicant will not unjustly discriminate among its customers as is prohibited under Section 392.200 RSMo.
8. Applicant is a competitive reseller of long distance telecommunications services and thus requests competitive classification pursuant to Section 392.361 RSMo and 4 CSR 240-2.060(6)(A). Applicant believes its proposed services will be subject to sufficient competition to justify a lesser degree of regulation. Further, when granted the Certificate requested herein, Applicant will be competing with other telecommunications companies in Missouri offering the same or similar services as Applicant.
9. Applicant is willing to comply with all applicable Commission rules, except those which are specifically waived by the Commission. Consistent with the Commission's treatment of other certificated competitive interexchange and local exchange telecommunications companies, Applicant requests that the following statutes and regulations be waived for Applicant and its interexchange and local exchange service offerings:


10. Applicant submits that the public interest will be served by Commission approval of this application because Applicant's proposed services will create and enhance competition and expand customer service options, and offer service options consistent with the legislative goals set forth in the federal Telecommunications Act of 1996 and Chapter 392 RSMo. Prompt

approval of this application also will expand the availability of innovative, high quality, and reliable telecommunications services within the State of Missouri.

12. The Company will not resell its services to other telecommunications companies.
13. Applicant is not aware of any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the application.
14. No annual reports or assessment fees are overdue from Applicant.

WHEREFORE, Applicant, M.L.M. Telecommunications, Inc. dba Ameritel, Your Phone Company, respectfully requests that the Commission (i) grant it a certificate of service authority to provide interexchange telecommunications services as requested herein; (ii) classify the Company and its proposed services as competitive; (iii) grant waivers of statutes and regulations as requested herein; and (iv) approve its separately submitted tariff.






