ORDER GRANTING RESPONDENT'S MOTION FOR ADDITIONAL TIME AND SETTING DEADLINE FOR RESPONSE TO COMPLAINANT'S MOTION FOR LEAVE TO FILE SUPPLEMENTAL TESTIMONY

On November 15, 2016, Moore Bend Water Utility, LLC, ("Moore Bend") filed a *Motion for Additional Time to File Rebuttal Testimony*. Moore Bend requests an extension of the November 18 deadline for filing rebuttal testimony, due to scheduling conflicts and the press of other business. Moore Bend states that counsel for all other parties in this case were notified of the request and that their respective clients have no objections. Finding the request to be reasonable and without objection, the Commission will grant Moore Bend's motion.
