MOTION FOR DEFAULT DETERMINATION**

On September 19, 2016, the Staff of the Missouri Public Service Commission filed a *Motion for Default Determination* requesting the Commission authorize its General Counsel's Office to seek civil penalties against Osage Water Company. Staff filed a *Complaint* against Osage Water Company on July 5. Respondent failed to file an answer by the August 13 deadline set by the Commission.

The Commission will set a deadline for Respondent to file a response to Staff's motion.

**THE COMMISSION ORDERS THAT:**

1. Osage Water Company may file a response to Staff's *Motion for Default Determination* no later than September 29, 2016.
