ORDER APPROVING ADDENDUM NO. 3 TO MISSOURI-AMERICAN WATER COMPANY'S SPECIAL CONTRACT WITH TRIUMPH FOODS, LLC.

Effective Date: May 21, 2016

On April 26, 2016, Missouri-American Water Company and Triumph Foods, LLC filed a Joint Motion asking the Commission to approve Addendum No. 3 to Missouri-American's special contract with Triumph. The motion explains that Missouri-American and Triumph (formerly known as Premium Pork, LLC) entered into a special rate contract in 2003. The Commission subsequently approved that contract, and a first addendum to that contract in File No. WT-2004-0192.

In 2010, Missouri-American and Triumph entered into a second addendum that redefined the commodity charge under the contract. That second addendum resulted from a stipulation and agreement approved in Missouri-American's rate case, File No. WR-2010-0131. The term of the second addendum expired on December 31, 2015 and needs to be extended. Testimony presented by Staff in this case recommends that the term of the addendum be extended and that the terms of the addendum be reviewed in Missouri-

American's next rate case. Public Counsel, Missouri-American, and Triumph concur, and no party has opposed that recommendation.

Missouri-American and Triumph have agreed to Addendum No. 3 to their special contract, which sets forth the rate as it currently exists and extends the term of Addendum No. 2 with no substantive changes. They now ask the Commission to approve Addendum No. 3.

On May 4, Staff filed a response to Missouri-American and Triumph's Joint Motion indicating it has reviewed Addendum No. 3 and recommends the Commission approve it.

The Commission will grant the Joint Motion and will approve Addendum No. 3. Because the Joint Motion is unopposed, the Commission will make this order effective in ten days.

THE COMMISSION ORDERS THAT:

1. The Joint Motion for Approval of Addendum No. 3 to Missouri-American Water Company's Special Contract with Triumph Foods, LLC is granted and Addendum No. 3 is approved.
2. This order shall become effective on May 21, 2016.
