**NOTICE REGARDING TARIFF FILING**

Missouri-American Water Company has filed a tariff designed to consolidate its existing multiple sewer tariffs into a single sewer tariff. Because the Commission ordered Missouri-American to take this action in the company's most recent rate case, File No. WR-2015-0301, Missouri-American filed its consolidated tariff in that file. The Commission's report and order in File No. WR-2015-0301 is currently on appeal to the Missouri Court of Appeals.

To avoid any confusion that would result from considering this new tariff in the old rate case file, the Commission has moved Missouri-American's tariff filing to a new file, File No. ST-2017-0261. All future filings regarding that tariff should be made in the new file.
