On March 30, 2016, the Commission issued an order directing Staff to file a status report no later than May 5, 2016. Since Missouri-American Water Company (Company) has not resolved the matter, Staff recommends the Company submit a report detailing the status of its attempts to resolve the issues mentioned by complainant, and any observed results of chemical water treatment adjustments. The Commission will direct the Company to file a report on this complaint.

THE COMMISSION ORDERS THAT:

1. Missouri-American Water Company shall file a report no later than August 5, 2016.

2. This order shall be effective when issued.


