On November 17, 2016, the Commission issued an *Order Granting Motion for Default Determination*, set to go into effect on November 28. In the Order, the Commission set a November 24 deadline for Missouri Utilities Company to file a motion requesting the Commission set aside the Order. On November 21, Missouri Utilities Company, through its Court-Appointed Receiver, Gary Cover, filed a *Motion to Set Aside Order Granting Motion for Default Determination*. The Commission will set a deadline for the filing of responses to the Motion.
