STATUS UPDATE

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Status Update*, respectfully states as follows:

1. Staff filed its *Complaint* on July 5, 2016, asserting that Osage Water Company (“Osage Water” or “Company”) failed to file its 2013, 2014, and 2015 annual reports, as required by Section 393.140(6), RSMo¹ and Rules 4 CSR 240-3.335(1) and 4 CSR 240-3.640(1).^{2, 3}

2. On December 16, 2016, Staff filed a *Status Update and Motion for Determination on the Pleadings*, outlining the case’s procedural history and providing support for a determination the pleadings.⁴

3. On December 21, 2016, Osage Water Company filed its *Response to Status Update and Motion for Determination on the Pleadings Filed by Staff of the*

Missouri Public Service Commission ("Response"). In its *Response*, Respondent stated, "Osage Water Company, by its Receiver, has in place a process to complete the Annual Reports for 2013, 2014, and 2015 and soon to be required Annual Report for 2016."⁵

4. Respondent also stated that it anticipated completion of its 2013 annual report by January 6, 2017.⁶

5. Respondent did not deny any of the allegations put forth in Staff's *Complaint* or Staff's *Status Update and Motion for Determination on the Pleadings*.⁷

6. On January 10, 2017, the Company filed its 2013 annual report, amended on January 16, 2017, and on January 26, it filed its 2014 annual report. To date, the Company has not filed its annual report for 2015. The Company also has not filed its annual report for 2016.

WHEREFORE, Staff submits its *Status Update*.
