**History:**

1. Staff filed its *Verified Complaint* in the above-styled matter on January 20, 2017, seeking authority for the General Counsel to pursue civil penalties.
2. On January 23, 2017, the Commission issued a *Notice of Contested Case* ("*Notice*") to Respondents. The *Notice* provided Respondents until February 22, 2017,<sup>1</sup> to answer the *Verified Complaint*.
3. Upon review of the EFIS Docket entries, Staff notes that it appears Notice of Service has not been completed for Respondent Ridge Creek Development, L.L.C.
4. Staff respectfully requests that the *Notice* be resent to Ridge Creek Development, L.L.C.'s Registered Agent at: Ridge Creek Development, L.L.C., 18499 Highway 133, Dixon, MO, 65459. Staff recommends Respondent Ridge Creek
