## ORDER SUSPENDING PROCEDURAL SCHEDULE AND DIRECTING FILING OF STATUS REPORT

The Commission previously established a procedural schedule in this matter and scheduled an evidentiary hearing for June 22, 2018. On May 25, 2018, the Staff of the Missouri Public Service Commission submitted a status report indicating that a final settlement agreement between Complainant and Respondent should be filed soon. Staff recommends the Commission suspend the procedural schedule pending a further update from Complainant or Respondent. No responses opposing Staff's recommendation were received.

Finding Staff's request to be reasonable, the Commission will suspend the procedural schedule and cancel the June 22, 2018 evidentiary hearing. The Commission will also set a deadline for Respondent to file a status report should a settlement not be reached.

#### THE COMMISSION ORDERS THAT:

1. The procedural schedule set by the Commission on March 12, 2018, is suspended. The evidentiary hearing scheduled for June 22, 2018, at 3:00 p.m. is canceled.

- 2. Missouri-American Water Company shall file either a copy of any agreement reached with Complainant or a status report on this case no later than July 9, 2018.
  - 3. This order shall be effective when issued.
