**ORDER GRANTING MOTION FOR EXTENSION OF TIME
AND SETTING TIME FOR RESPONSES**

On July 3, 2018, Thirty and 141, L.P., filed a complaint with the Missouri Public Service Commission (Commission) against Missouri American Water Company. Thereafter, the Commission ordered the Staff of the Missouri Public Service Commission (Staff) to investigate and file a report no later than September 6, 2018. On September 5, 2018, Staff requested an extension of time in which to complete its investigation, indicating it was waiting for responses to data requests. Staff also indicated that it has conferred with both parties, and neither objected to the request for extension of time.

The Commission finds that the request for extension is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension filed by the Staff of the Missouri Public Service Commission on September 5, 2018, is granted.

2. The Staff of the Missouri Public Service Commission shall file its investigation report and any recommendations no later than October 5, 2018.

3. Any responses to the Staff's investigation report shall be filed no later than October 15, 2018.

4. This order shall be effective when issued.
