ORDER DENYING MOTION FOR WAIVER AND AMENDING PROCEDURAL SHEDULE

Issue Date: September 10, 2014 Effective Date: September 13, 2014

The Commission is denying Staff's *Joint Motion for Waiver and Proposed Amended Procedural Schedule* ("joint motion") ¹ because the proposed procedural schedule would exceed the 11-month time frame prescribed by the Commission's regulation.

The Commission's regulation sets a time frame for disposition 11 months after commencement of the action. ² Because the case began on December 2, 2013, the 11 month deadline is November 2, 2014. The procedural schedule as currently ordered is within that time frame ³ but is the subject of several proposals to amend, which compare as follows.

The Office of the Public Counsel ("OPC") filed a motion proposing changes to the procedural schedule that fall within the regulation's time frame. ⁴ Hickory Hills Water & Sewer Company ("Hickory Hills") filed a motion setting forth conflict dates when Hickory Hills' receiver will be out of the country. ⁵ The Commission proposes a hearing date of September 26, which keeps this action within the time frame and accommodates the receiver's travel schedule. ⁶

By contrast, the joint motion exceeds the time frame without any proffered reason, and offers no suggestion against the Commission's September 26 hearing date. Also, the joint motion suggests dates for filing documents while, or just after, Hickory Hills' receiver will be out of the country. And Hickory Hills does not join in the motion.

Therefore, the Commission will deny the motion and amend the procedural schedule as set forth in the ordered paragraphs. Because Hickory Hills still has until noon on September 12 to file a response to the proposals of the Commission and OPC, ⁷ the Commission will make this order effective on September 13.

THE COMMISSION ORDERS THAT:

- 1. The Joint Motion for Waiver and Proposed Amended Procedural Schedule is denied.
 - 2. The procedural schedule is amended as follows.
