STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Recommendation to Approve Tariff Sheets* in this matter, hereby states:

1. The Commission on July 26, 2017, issued its Order Approving Disposition Agreements and Small Company Rate Increase in the above-referenced matter. Terre Du Lac Utilities Corporation (Company) on August 30, 2017, filed proposed Revised Tariff(s) to update its existing tariff sheets based on the Commission's Order.

2. Staff has reviewed the tariff sheets and finds them to be compliant with the Commission's *Order* excepting one detail. Along with the *Unanimous Stipulation and Agreement* filed in this matter the parties filed an attached *Proposed Rate Design*. The rate design reflected a proposed service charge for water rates of \$14.50 for 5/8" and 3/4" meters. After filing the parties learned of an error in calculations and corrected that proposed service charge to what is now reflected in the tariffs, \$14.85. This corrected rate is consistent with the gross annual revenue requirement listed in the *Order*. No other changes resulted.

3. In support of its *Recommendation*, Staff has attached the Affidavit of Curtis Gateley to this pleading and incorporates the same herein by reference.

WHEREFORE, Staff prays that the Commission will accept Staff's *Recommendation;* approve Terre Du Lac Utilities Corporation's proposed tariff sheets; and grant such other and further relief as the Commission considers just in the circumstances.
