ORDER DIRECTING RECOMMENDATION ON TARIFFS

Issue Date: July 19, 2022

Effective Date: July 19, 2022

On June 29, 2022, the Commission issued an *Amended Report and Order* in this matter, effective July 9, 2022. Among other things, that order directed Missouri-American Water Company (MAWC) to submit tariff sheets applicable to the water service and sewer service in the requested service area in P.S.C. MO No. 13 (water) and 26 (sewer), to become effective before closing on the assets.

On July 5, 2022, MAWC filed new tariff sheets purporting to be in compliance with the terms of the Commission’s June 29th order. The new tariff sheets carry a 30-day effective date of August 4, 2022.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted tariff sheets comply with the Commission’s June 29th order.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding MAWC’s new tariff sheets (Tariff Nos. YW-2023-0246 and YS-2023-0007) no later than July 22, 2022.

2. This order shall be effective when issued.
