ORDER GRANTING EXTENSION OF TIME

Issue Date: October 3, 2022 Effective Date: October 3, 2022

On June 29, 2022, the Commission issued its *Amended Report and Order*. Ordered paragraph 3.f. stated:

MAWC [Missouri-American Water Company] shall develop a plan to book all of the Eureka plant assets, with the concurrence of Staff and/or with the assistance of Staff, for original cost, depreciation reserve, and contributions (CIAC) for appropriate plant accounts, along with reasonable and prudent transaction, closing, and transition costs. This plan should be submitted to Staff for review within sixty (60) days after closing on the assets.

On October 3, 2022, Missouri-American Water Company (MAWC) filed *MAWC's Motion for Extension*. The motion states that MAWC closed on the Eureka assets on August 4, 2022, but "has not yet completed the compilation of the information required to provide for Staff's review a plan [sic] to book the Eureka assets, primarily due to the quantity of assets involved."

Sixty (60) days from the August 4th closing date is October 3, 2022. MAWC's motion requests a 30-day extension to November 2, 2022. The Staff of the Commission (Staff) does not oppose the motion.

The Commission finds the motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

- 1. MAWC's motion is granted. MAWC shall develop a plan to book all of the Eureka water and sewer plant assets, with the concurrence of Staff and/or with the assistance of Staff, for original cost, depreciation reserve, and contributions (CIAC contributions in aid of construction) for appropriate plant accounts, along with reasonable and prudent transaction, closing, and transition costs. This plan shall be submitted to Staff for review no later than November 2, 2022.
 - 2. This order shall be effective when issued.
