ORDER APPROVING TARIFF

On November 9, 2021¹, Missouri-American Water Company (“MAWC”) filed tariff sheets, effective December 9, to allow it to provide water service in the City of Garden City, Missouri. The Commission Staff filed its Recommendation on November 19, advising the Commission to approve the submitted tariff filing.

The Commission has authority to approve tariff sheets pursuant to Sections 393.140(11) and 393.150, RSMo. The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission finds that the tariff sheets conform to the Commission's order granting MAWC the certificate of convenience and necessity. Thus, the Commission will approve the tariff sheets.
