**ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND
SETTING A TIME FOR RESPONSES**

Issue Date: July 13, 2021

Effective Date: July 13, 2021

On June 28, 2021, the Commission directed its Staff (Staff) to file a pleading indicating when Staff could file a recommendation regarding Confluence Rivers Utility Operating Company’s (Confluence Rivers) certificates of convenience and necessity (CCN) applications. Staff states that it can file a recommendation by October 5, 2021.

The Commission will order its Staff to file a recommendation regarding Confluence Rivers’ applications, and shall set a time for any responses.

Staff’s recommendation shall include whether each system Confluence Rivers is asking to acquire should be addressed as a separate CCN application, and whether the water and sewer CCN applications should be consolidated.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Confluence Rivers’ CCN applications no later than October 5, 2021.

2. Any responses to Staff's recommendation or Confluence Rivers' applications shall be filed no later than October 19, 2021.

3. This order is effective when issued.
