### STAFF'S COMPLIANCE TARIFF RECOMMENDATION

)

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), through counsel, and recommends that the Commission approve the proposed tariff sheets Missouri-American Water Company ("MAWC") filed on October 2, 2022 bearing effective dates of November 1, 2022.

1. On August 31, 2022, in its Order, the Commission granted MAWC a Certificate of Convenience and Necessity to provide water and sewer service in the service areas currently served by the City of Purcell ("Purcell"). The Commission also ordered MAWC to file tariff sheets, to become effective before closing on the assets.

2. On October 2, 2022 MAWC filed its proposed tariff sheets in tariff tracking numbers YW-2023-0061 and YS-2023-0062, with proposed effective dates of November 1, 2022.

3. On October 2, 2022, MAWC moved the Commission for expedited treatment of these proposed tariff sheets so they go into effect with less than 30 days notice on October 25, 2022. Staff has no objection to the tariff sheets being effective with less than 30 days notice.

4. On October 3, 2022 the Commission directed Staff to file a recommendation regarding these tariff sheets by October 7, 2022.

5. Staff reviewed all tariff sheets and concluded that they comply with the Commission's October 3, 2022 order.
