On May 24, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed the above-referenced applications. On May 30, 2023, Confluence filed a motion to consolidate. No party objected.

The Commission finds these two cases involve related questions of law and fact such that consolidation is permissible under Commission Rule 20 CSR 4240-2.110(3). Thus, the Commission will grant the motion to consolidate.

The Commission has issued notice of these applications, and the Commission has received no requests to intervene. Thus, the Commission will order its Staff to file a Recommendation.

1. The motion to consolidate is granted, with File No. WA-2023-0398 being the lead file.
2. The Commission's Staff shall file a Recommendation no later than July 12, 2023.
