ORDER AND NOTICE OF LOCAL PUBLIC HEARING

The Missouri Public Service Commission is setting a local public hearing, in accordance with the suggestion filed by Staff on behalf of all parties,¹ and setting dates for related filings.

THE COMMISSION ORDERS THAT:

1. Schedule. The Commission will convene a local public hearing on the application that is the subject of this action ("the application") as follows.

6:00 p.m., December 19, 2017
The Community Center, River & Bluff Rooms,
1530 West Jackson Street,
Ozark, MO 65721.

That space meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference shall contact the Commission not later than the day before such event. Such contact shall be through the Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711.

2. Statements. At the local public hearing, The City of Ozark, The Public Funding Corporation of the City of Ozark, the Commission's staff ("Staff"), and the Office of the

Public Counsel ("OPC") shall each set forth its perspective on the application by making available:

- a. A written statement, not more than one page, with sufficient copies for the attendees; and
- b. At least one representative in person to address substantive issues and respond to questions from the attendees.

3. Question-and-Answer Session. The local public hearing shall begin with a question-and-answer session. At the question-and-answer session, the Commission's staff ("Staff") shall make a presentation on the application. Staff and representatives of other parties to this case will answer questions about the application.

4. Public Testimony. At the close of the question-and-answer session, a regulatory law judge shall take public testimony.

5. Related Filings.

- a. Not later than January 8, 2018, OPC shall file its response to the application and Staff's recommendation.
- b. Any reply to OPC's response shall be filed no later than January 18, 2018.

6. Notice.

- a. The applicant shall provide an individual notice to each of its customers no later than ten days before the local public hearing.
- b. The Commission's Data Center shall serve a copy of this notice and order on the governing body of each county in the applicant's service areas.

c. The Commission's Public Information Office shall make this notice and order available to members of the General Assembly representing the residents of the applicant's service areas.

7. Effective Date. This order is effective when issued.
