## ORDER CANCELING CERTIFICATE

On June 27, 2018, the Commission issued an order approving the application of the Public Funding Corporation of the City of Ozark ("PFC") seeking authority for a transfer of its assets from the PFC to the City of Ozark, Missouri ("City") and the cancellation of the certificate of convenience and necessity authorizing PFC to provide water service to the public. As part of its order, the Commission directed PFC to file a notice indicating when the closing on the transfer of assets was complete. The City filed notice on September 18, 2018, indicating that the transfer was completed on that day. Because of the transfer, PFC is no longer providing water service. As provided in the order issued on June 27, 2018, the Commission will now cancel PFC's certificate of convenience and necessity to provide water service.

### THE COMMISSION ORDERS THAT:

1. The Public Funding Corporation of the City of Ozark's Certificate of Convenience and Necessity to provide water service is canceled.

2. This order shall be effective when issued.
