APPLICATION FOR APPROVAL OF INTERCONNECTION AGREEMENT

COMES NOW Missouri Telecom, Inc., (Missouri Telecom), and files its Application for Approval of Interconnection Agreement (Agreement) between Missouri Telecom and Southwestern Bell Telephone Company (SWBT) under the Telecommunications Act of 1996 (Federal Act). In support of that Application, Missouri Telecom states as follows:

I. INTERCONNECTION AGREEMENT REACHED

Missouri Telecom presents to this Commission for approval an Interconnection Agreement entered into between SWBT and Missouri Telecom, executed pursuant to the terms of the Federal Act. A copy of the Agreement is provided as Exhibit A. The Agreement consists of 610 pages numbered seriatim in the bottom right corner, including 24 attachments, 12 appendices, and 2 exhibits which are incorporated into the Agreement. There are no outstanding issues between Missouri Telecom and SWBT that need the assistance of mediation or arbitration. The Agreement adopts the terms of the AT&T/SWBT Agreement approved by the Commission in Case Nos. TO-97-40 and TO-98-115, pursuant to Section 252(i) of the Federal Act.¹

¹In a footnote appearing on seriatim Page 39, which is also numbered Page 39 of 39 of General Terms and Conditions, SWBT has reserved certain rights and asserts that SWBT "has signed this document under compulsion of federal and/or state law."

II. REQUEST FOR APPROVAL

Missouri Telecom seeks the Commission's approval of the Agreement, consistent with the provisions of the Federal Act and Missouri law. The implementation of this Agreement complies fully with Section 252(e) of the Federal Act because the Agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier.

Missouri Telecom respectfully requests that the Commission grant expeditious approval of this Agreement, without change, suspension or other delay in its implementation. This is a bilateral agreement, reached as a result of negotiations and compromise between the parties.

The agreement includes seriatim page numbers in the lower right hand corner of each page; thus, the Commission should not need to order an additional page-numbered copy of the Agreement to be filed upon approval.

III. STANDARD FOR REVIEW

The statutory standards of review are set forth in Section 252(e) of the Federal Act which provides as follows:

- (e) Approval by State Commission
 - (1) Approval required.—Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A State commission to which an agreement is submitted shall approve or reject the agreement, with written findings as to any deficiencies.
 - (2) Grounds for rejection.--The state commission may only reject--
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that—

- (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
- (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity.

IV. MISSOURI LAW

The executed Agreement is consistent with Missouri Law.

V. CONCLUSION

For the reasons set forth above, Missouri Telecom respectfully requests that the Commission approve the Agreement expeditiously.
