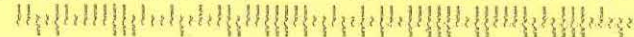

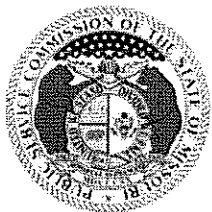
On November 2, 2017, Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers”) filed applications seeking, among other things, authority for Confluence Rivers to buy the assets of twelve water and sewer companies, and to then provide water and sewer service to the customers of those companies. The Commission gave notice to the public, and received no intervention requests.

The Commission ordered its Staff to file a pleading no later than December 21, 2017. Staff responded timely, stating it needed until February 20, 2018 to file a Recommendation or alternative pleading. On February 16, 2018, Staff responded, asking for the Commission to order Staff to file a further pleading no later than March 6, 2018.

The Commission finds the request reasonable, and will order Staff to file a responsive pleading.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than March 6, 2018.
2. This order shall be effective when issued.




