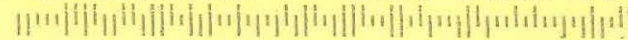

On November 2, 2017, Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers”) filed applications seeking, among other things, authority for Confluence Rivers to buy the assets of twelve water and sewer companies, and to then provide water and sewer service to the customers of those companies.

The Commission directed notice of the application be given to the public, and allowed interested parties until November 20, 2017 to apply to intervene. The Commission received no intervention requests.

The Commission will now order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than December 21, 2017.
2. This order shall be effective when issued.




