ORDER APPROVING TARIFFS

Issue Date: June 22, 2021

Effective Date: July 8, 2021

On December 9, 2020, the Commission issued its *Order Approving Acquisition of Water and Sewer Assets and Granting Certificates of Convenience and Necessity*, authorizing Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) to acquire certain water and sewer assets, including the water utility assets of Fawn Lake Water Corp. (Fawn Lake). The Commission's order granted certificates of convenience and necessity to Confluence Rivers for multiple systems, including Fawn Lake, and directed Confluence Rivers to submit tariff filings for those systems.

On June 8, 2021, Confluence Rivers filed tariff sheets, assigned Tariff No. YW-2021-0224, addressing Fawn Lake. The tariff sheets bear a proposed effective date of July 8, 2021. On June 14, 2021, Confluence Rivers filed substitute tariff sheets to correct two sheets filed on June 8, 2021.

On June 16, 2021, the Staff of the Commission recommended that the Commission approve the proposed tariffs. No party has filed a response to Staff's recommendation.¹ The Commission has reviewed the tariff filing and Staff's

recommendation and concludes the tariff sheets should be approved in compliance with the Commission's December 9, 2020 order. To approve the tariff sheets to take effect on the requested date, this order will be effective on July 8, 2021.
