ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND SETTING A TIME FOR RESPONSES

On December 1, 2021, the Commission directed its Staff (Staff) to file a pleading stating the date it would be able to file a recommendation on Carl R. Mills' application to transfer his water system assets to Carriage Oaks Estates Water and Sewer Not-For-Profit. Staff responded that it can file a recommendation by March 10, 2022. The Commission will direct Staff to file a recommendation by that date and set a time for responses.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Carl R. Mills' application no later than March 10, 2022.
2. Any responses to Staff's recommendation or Carl R. Mills' application shall be filed no later than March 21, 2022.
3. This order is effective when issued.
