# STAFF'S SUPPORT OF TARIFF SHEETS

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its motion supporting the revised tariffs filed by Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities, formerly known as Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities, respectfully states to the Missouri Public Service Commission (Commission) the following:


