RECOMMENDATION FOR APPROVAL OF TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through Counsel, and for its <u>Recommendation for Approval of Tariff Sheets</u> states the following to the Missouri Public Service Commission (Commission).

- 1. On August 4, 2005, the Commission issued its <u>Order Approving Sale of Assets</u> (Order) in this case, in which it approved the sale of the utility assets of Silverleaf Resorts, Inc. (Silverleaf) to Algonquin Water Resources of Missouri, LLC (Algonquin). As a part of its Order, the Commission directed Algonquin to submit the tariff sheets necessary to accomplish its adoption of Silverleaf's existing approved tariffs.
- 2. On August 23, 2005, Algonquin submitted three sewer tariff sheets and three water tariff sheets intended to be in compliance with the above-referenced Commission Order. The subject tariff sheets bore an issue date of August 23, 2005 and an effective date of September, 22, 2005. Upon being entered into the Commission's electronic filing and information system, the sewer tariff sheets were assigned Tariff File No. YS-2006-0126 and the water tariff sheets were assigned Tariff File No. YW-2006-0127.

3. The Staff has reviewed the tariff sheets that Algonquin submitted to the Commission on August 23, 2005 and is of the opinion that the subject tariff sheets are in compliance with the Commission Order referenced in Paragraph 1. above. (Jim Merciel and Dale Johansen of the Commission's Water & Sewer Department performed the review of the subject tariff sheets on behalf of the Staff.)

4. Upon Commission approval of the subject tariff sheets, no further action will be needed in this case and the case may thus be closed.

WHEREFORE, the Staff respectfully recommends that the Commission issue an order that: (a) approves the tariff sheets pending in Tariff File Nos. YS-2006-0126 and YW-2006-0127 to be effective September 22, 2005; and (b) closes this case.
