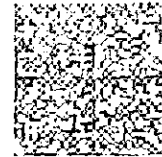

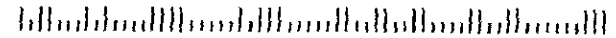

**ORDER GRANTING MOTION TO SHORTEN TIME FOR RESPONSES**  
**TO DATA REQUESTS**

On February 8, 2007, Folsom Ridge, L.L.C. and Big Island Homeowners Water and Sewer Association, Inc. (collectively "Applicants") filed an application pursuant to Commission Rules 4 CSR 240-2.015 and 2.090(2) requesting the Commission to shorten the time for all parties to respond to data requests. In support of its motion, Applicants assert that because interveners were given party status on February 7, and because the hearing in this matter is scheduled for February 28, the normal application of the rules allowing ten days to object to data requests and twenty days to respond to data requests after service should be shortened. Applicants propose that the time period for answering data requests be shortened to ten days after service, and that the time limit for objecting to data requests be shortened to five days after service.

The Commission finds that in the interest of fairness and justice, and for good cause shown, that the Commission will shorten the time for responding to data requests.

**IT IS ORDERED THAT:**

1. The time period for answering data requests in this matter is shortened to 10 days after service.
2. The time period for objecting to data requests in this matter is shortened to 5 days after service.
3. This order shall become effective on February 9, 2007.
