Pilot Study Program Overview:

Discount: The current fixed monthly 5/8" meter minimum customer charge for District 2 is \$15.33, the discount applied to the customer's monthly bill would be \$12.66 (e.g., "fixed" customer charge is \$2.67 with volumetric charge unchanged.

Eligibility: The minimum customer charge rate for low-income customer pilot in District 2 is eligible for ratepayers whose overall household earnings meet the low-income guidelines for the Missouri Low-Income Home Energy Assistance Program ("LIHEAP").

Criteria: Customers that default on payments for two (2) consecutive months will no longer be eligible for this rate, and will not be allowed to requalify for twelve (12) months. Customers must establish eligibility on an annual basis.

Question posed by Chairman Hall:

<u>Chairman Hall:</u> Well, how many—what is the participation in the program thus far?

Mr. Weston: Let—let me check real quick. We think it's about 120 customers at this point. Chairman Hall: Any idea as to how that compares to---to the number that would be eligible?

Mr. Weston: I—I don't know that off the top of my head, Chairman. I don't know if—if we know that right now at this point in time.

<u>Chairman Hall:</u> Because I would—I would have to believe that that is a number that is attainable. I mean, you could go the Community Action Center, and I—

<u>Dr. Marke:</u> Chairman, we could get a hold of that number. Probably the easiest way would be to contact Social Services that administers LIHEAP and just find out the LIHEAP percentage that was allocated last year for the St. Joe Area.¹

Response:

With data provided by Missouri American Water and the Missouri Department of Social Services, Table 1 provides a breakdown of District 2 by zip code, residential customer accounts and LIHEAP recipients living within the same zip code. Contextual Information on LIHEAP

LIHEAP is not an entitlement program. Therefore, the program's grantees are unable to serve all of the households that are income eligible under the federal maximum income eligibility standard. On a nation-wide basis, in Fiscal Year 2014, only 16 percent of income eligible households received heating and/or winter crisis assistance. Given that limitation, the LIHEAP statute requires LIHEAP grantees to provide, in a timely manner, that the highest level of assistance will be furnished to those households that have the lowest incomes and the highest energy costs or needs in relation to income, taking into account family size.

Individual states have the option of imposing a lower maximum annual income level, but no state outside of Hawaii and Alaska can disperse LIHEAP funding to households who annual income exceeds 150% of the federal poverty level (\$36,450 for a family of four).

Missouri utilizes a lower maximum annual income eligibility level at 135% of the federal poverty line as can be seen in Table 2
