ORDER GRANTING APPLICATIONS TO INTERVENE

The Commission set a July 25, 2017 deadline for the filing of applications to intervene in Missouri-American Water Company’s request for a general rate increase. The City of St. Joseph, Missouri (“St. Joseph”) and Triumph Foods, LLC (“Triumph”) each filed timely applications to intervene. Although Commission Rule 4 CSR 240-2.080(13) allows parties ten days to file a response, no responses to St. Joseph’s or Triumph’s applications were received. Therefore, the Commission will consider the unopposed applications to intervene.

The Commission finds that both applicants have an interest in this case that differs from those of the general public and that those interests may be adversely affected by a final order in this case. The Commission also finds that allowing St. Joseph and Triumph to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the applications to intervene.

THE COMMISSION ORDERS THAT:

1. The City of St. Joseph’s Application to Intervene is granted.
2. Triumph Foods, LLC’s Application to Intervene is granted.

3. This order shall be effective when issued.
