APPLICATIONS TO INTERVENE**


On July 5, 2017, the Commission issued an order setting a July 25, 2017 deadline for the filing of applications to intervene. On July 25, 2017, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (jointly “KCP&L/GMO”) and Union Electric Company d/b/a Ameren Missouri, filed applications to intervene. On August 4, 2017, the Office of the Public Counsel (“OPC”) filed *Public Counsel’s Opposition to the Applications for Intervention of Ameren Missouri, Kansas City Power & Light Company, and KCP&L Greater Missouri Operations Company*. The Commission will set a deadline for Ameren Missouri and KCP&L/GMO to submit responses to OPC’s filing.

**THE COMMISSION ORDERS THAT:**

1. No later than August 8, 2017, Union Electric Company d/b/a Ameren Missouri may file a response to OPC’s opposition to the company’s intervention request.
2. No later than August 8, 2017, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company may file responses to OPC’s opposition to their intervention requests.

3. This order shall be effective when issued.
