**ORDER SUSPENDING TRUE-UP PROCEDURAL SCHEDULE AND SETTING
DEADLINE FOR FILING RESPONSE**

On March 26, 2018, Missouri-American Water Company and the Office of the Public Counsel (jointly, the “Signatories”) filed a *Stipulation of Fact Related to True-Up and Motion to Suspend True-Up Procedural Schedule*. The Signatories state an agreement was reached on the sole fact remaining at issue in the true-up process. The Signatories request the Commission suspend the March 27, 2018 deadline for filing rebuttal testimony and the April 2, 2018 true-up hearing, since the Signatories agree that any argument concerning the facts stipulated to by the Signatories may be addressed in initial and reply briefs.

The Commission will temporarily suspend the deadline for filing rebuttal testimony and the scheduled true-up hearing while other parties are given an opportunity to object to the *Stipulation of Fact Related to True-Up and Motion to Suspend True-Up Procedural Schedule*. Should no party oppose the Signatories’ filing, the temporary suspension would become permanent.

THE COMMISSION ORDERS THAT:


1. The March 27, 2018 deadline for filing true-up rebuttal testimony shall be suspended unless the Commission orders otherwise.

2. The April 2, 2018 true-up evidentiary hearing shall be suspended unless the Commission orders otherwise.

3. Responses to the *Stipulation of Fact Related to True-Up and Motion to Suspend True-Up Procedural Schedule* may be filed no later than March 28, 2018.

4. This order shall be effective when issued.
