ORDER DIRECTING RESPONSE

On January 13, 2021, Derald Morgan filed a formal complaint against Carl R. Mills Water Service d/b/a Carl Richard Mills. Separately, Mr. Morgan intervened in Carl Richard Mills' small utility rate case, File No. WR-2021-0177. Mr. Morgan was a signatory to the unanimous disposition agreement in that rate case.

Following the unanimous disposition agreement in the rate case, this complaint file remained open to allow discovery and opportunities for the parties to discuss potential resolutions. Except for status reports, no further action has been taken.

On November 1, 2021, Mr. Morgan filed a motion for summary determination. The Commission will direct a response be filed by Carl Richard Mills, and will set a timeframe to allow responses by other parties.

THE COMMISSION ORDERS THAT:

1. Carl R. Mills Water Service d/b/a Carl Richard Mills shall file a response to the November 1, 2021, motion for summary determination of Mr. Morgan on or before December 6, 2021.

2. Any other party wishing to file a response to the motion for summary determination shall do so on or before December 6, 2021.

3. This order shall be effective when issued.
